1. **Fill in this order form and send it to us via e-mail.**
2. **Send us your glass slides in suitable packaging.**

We will digitize your slides and return them in the same manner. You will need to send us your data storage (pendrive, USB stick or external HDD) or order from us an appropriate storage device to provide you with the virtual slides in standard Panoramic slide format with .mrxs extension or we will host them in CaseCenter or on the Pathonet website depending on your choice.

- Standard slides can be accepted only (76mm X 26 mm \ 1.2 mm with coverslip).
- During the FL scanning, despite the professional care, the slides might be damaged.

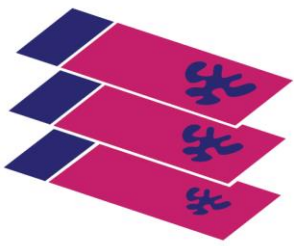

STANDARD SCANNING SERVICE TERMS & CONDITIONS

By ordering slide scanning services from 3DHISTECH, you acknowledge and agree the following standard scanning service terms and conditions:

1. Slide scanning services shall only be accepted if the total amount of the service fee shall be paid in advance against 3DHISTECH's pro-forma invoice.
2. For tryout purposes, scanning of one (1) slide can be ordered without prepaid terms. In this case, you shall be obliged to pay the service fee within 8 days after getting the digital slide, against 3DHISTECH's invoice.
3. 3DHISTECH shall send you your digital slides (and/or instructions for access to the stored slides) and after your successful receipt, 3DHISTECH shall return your material slides. You shall verify the reception of and/or access to the virtual slides in 5 days.
4. 3DHISTECH shall accept and scan only fixed-tissue slides.
5. The digital slide images shall be used only for research and education purposes.
6. Protected health information shall not be disclosed to 3DHISTECH. In addition, you and 3DHISTECH shall enter into an obligation to treat all explicitly marked information confidential obtained during the collaboration with each other, and shall protect and hold in confidence all confidential information.
7. 3DHISTECH shall make every effort to perform the scanning services and return and share the digital slides to you within five (5) business days for ten (10) slides or less, and within seven (7) business days for fifty (50) slides or less, after we receive the glass slides. Scanning of fluorescent slides can take longer.
8. Performing deadline shall not be guaranteed.
9. You shall package and send the glass slides in a safe and secure way to ensure that the slides are protected against breakage or any other damage.
10. 3DHISTECH shall handle the glass slides with professional care. If 3DHISTECH accidentally damages your glass slides, as sole remedy provided to you, 3DHISTECH shall scan additional glass slides of your choosing, equal to the number of damaged slides, at no additional cost to you.
11. 3DHISTECH shall not be liable for any damages to your slides that occur during shipment or that are the result of improper packing of the slides by you.

12. 3DHISTECH shall return the slides in suitable packaging.
13. 3DHISTECH reserves the right to reject any order in its sole discretion.
14. 3DHISTECH reserves the right to terminate any services immediately upon written notice if you violate any provision of this cooperation.
15. 3DHISTECH disclaims all warranties, express or implied, including the implied warranties of merchantability or fitness for a particular purpose.
16. 3DHISTECH is not liable for any consequential, exemplary, special, indirect or incidental damages or for any damages caused by a delay in furnishing scanning services.
17. 3DHISTECH is not liable for damage of whatever nature (including, but not limited to, general or specific damage, indirect damage, consequential damage or incidental damage, including the results of the analysis of the digitalised slides, for example: change of health status related to erroneous diagnosis from the digitalized slide(s)) that is associated with digitalized slides, quality of staining, quality of stained slides, quality of used method of staining.
18. This agreement shall be governed, construed and enforced in accordance with the laws of the State of Hungary, without regard to its conflict of laws rules.
19. All disputes arising from or in connection with the present service, its breach, termination, validity or interpretation, shall be exclusively decided by the Court of Arbitration attached to the Hungarian Chamber of Commerce and Industry, Budapest in accordance with its own Rules of Proceedings.
20. The terms and conditions set forth hereto shall be regarded as the entire agreement between you and 3DHISTECH relating to scanning services. Any other document or arrangement, which is inconsistent with the terms of this document, shall be deemed null and void.
21. The rights and obligations are not assignable to any third party without the written consent of the other party.
22. In the event that any one or more of the provisions contained hereto shall for any reason be held to be invalid, illegal or unenforceable in any respect, this arrangement shall be enforced to the maximum extent possible.
23. Any notice to be given shall be sent by registered or certified mail, email, postage prepaid, or by overnight courier service towards the official addresses of the respective parties.
